Section 2: Summary of application
In no more than 400 words please use this space to describe your project (see guidance for more information).
The Three 9's challenge is a Police lead multi agency, sustainable, youth intervention strategy. Schools based policing officers Pc's Andrew Hand and David Case devised the project in 2005. It involves taking referrals from young people aged 10 - 16yrs whom have been identified for a variety of reasons to either be at risk of offending or are vulnerable. Referrals to the project come from multi agency sources including schools, the YOT, youth services, schools, Police Officers, Connexions and agency partners. (An example of best practice having been identified within the Police/YOT in referring to the project as a condition of a youth offender receiving a 'final warning')
Important factors written into the project were that it must inclusive for all participants and sustainable over an extended period of time. In addition to being educationally based it also looks at issues of self-awareness, citizenship and the raising self-esteem.
Having been identified and assessed the young people are contacted and arrangements made to explain the process of the 10 month programme and the expectations from it. A system of mentoring is then put in place for all of them involving youth services, YISP (Youth Inclusion Support Programme), YOT (Youth Offending Team, Schools Policing officers, Education Welfare officers and the respective schools - this is done in order to assess areas for individual development and to set goals. (Example - monitored improvements in school attendance or behaviour/offending issues). At this point all students sign up to an acceptable behaviour contract (ABC) in relation to their commitment to the project and related activities. The students agree to be monitored throughout the whole of the 10-month challenge period - significant breach of the contract would result in exclusion from the programme.
The project is broken into four individual challenge modules that take place over each of the school holiday periods through the school year - each one is designed to challenge, develop and test new skills as both individuals and as team members. All activities within the modules of the project have been individually risk assessed and the project itself has a legally compliant policy, in relation to health and safety.

Section 3: Description of project

Aims

The Three 9's Challenge project engages disaffected and disadvantaged young people aged 10 - 16, to promote positive behaviour, enhance life skills and improve school attendance over a ten-month period.

Objectives

The project provides a programme of intervention throughout the school holidays to;

- Establish a mentoring framework
- Develop citizenship / life skills within young people
- Deliver formal qualifications in First Response Basic Life Support
- Positively address and reduce patterns of criminality
- Reduce victimisation
- Develop personal safety

<u>Partnership</u>

The multi-agency partnership works to deliver the objectives detailed above. The partners consist of Nottinghamshire Police, Nottinghamshire Fire & Rescue Service, St John's Ambulance, Nottinghamshire County Council Trading Standards and Road Safety Dept, and Nottingham City Council Trading Standards and Road Safety Dept. As the projects develops it may be necessary to extend the partners, subject to agreement by existing partnerships. (See Appendix A - Business plan)

The Roles of Partners

The Three 9's Challenge is delivered within four modules over a period of ten months. Young People are referred by Youth Offending Teams, Schools, etc.

The four modules take place over each of the school holiday periods throughout the year - each module is designed to challenge, develop and test new skills of young people as both individuals and as team members.

The work performed by the respective agencies within the defined modules is formulated by the evaluation of current youth related trends and issues. This allows agencies to deliver inputs in relation to their own role specific work agendas and within the boarder "joined up" remit of the whole initiative.

Module 1 – August

Each young person referred to the project will undergo an assessment meeting between the person and the respective parent/carers during which the individual's goals/objectives are set along with the means by which they are to be measured. (See Appendices B & C - Student referral/application form including ABC and promotional flyer)

With comparable data analysis being one of the means by which changes are to be evidenced, statistics are gathered to give a true picture of the referred individual in relation to their specific target area's. (E.g. truancy percentages, levels of offending)

A continual mentoring and assessment framework will be put in place using multi agency partnership members in order to monitor the individuals' performance set against their individual objectives. Mentoring meetings will take place to establish a means of early identification of development issues and to establish a positive ethos to progress and encourage the individual. This mentoring will also provide a mechanism for early intervention strategies to be implemented if necessary, again using all the skills available through the multi agency partners.

Review meetings for the partnerships and mentors are set at six weekly intervals to assess the referrals performance and progressive strategies discussed and agreed.

The mentoring framework could include members of youth services, schools, community workers, youth offending team workers, Connexions, health workers or Police officers.

Utilizing the skills within this team is an essential ingredient to impacting and effecting change in the lives of the young people. The ultimate sanction for the young person is removal from the project but such is the strength within the team partnership that currently no one has been excluded in this way to date, as exclusion is very much viewed as disengagement for the individual concerned.

A young person eligible for graduation having completed the 10-month project must have positive evidence of progression during that period. This will be achieved through updated and comparable 'multi agency' statistical analysis that is relevant to the set goals and objectives for the specific individual.

The project in its first two years of operation has proved to be an outstanding success.

In the first year, 49 young people successfully completed the programme and in this the second year 120 are on course to graduate in May. Changes in the lives of the young people involved have been evidenced in a number of ways with reductions in numbers of offences, arrests and fewer victims amongst the vulnerable groups. Truancy and attendance figures have improved. The designated areas of the project operation have also been identified as being amongst the few in the country to have achieved government targets in relation to truancy reduction.

On a strategic level The Practioner Working Group will meet four times a year, prior to each module.

The Strategic Board will meet once a year after the completion of Module Four to assess the past course and define the strategy for coming year.

The agency partners have all signed up to a policy/service level agreement document relating to roles and responsibilities and making an agreement to support its aims and objectives. The partnerships are also committed to project workings under a locally agreed policy relating to both health and safety practices and risk assessment for all activity provisions. (See appendices D and E - Heath and safety policy and sample risk assessment documents)

Funding, sustainability and project progression

The true cost of the project to date has been hidden, via the generosity of Partners who have donated time and resources. However for future planning, we are in the process of costing each Partner's involvement for service provision. (This is to include hours worked on the project, telephone calls, stationary, provision of activities, etc.)

An application is currently pending by the St John Ambulance service for project funding of £150,000 to implement planned expansion over a five year period. This will include the appointment of a full time project administrator / coordinator.

This planned expansion of the project into other areas of the county is briefly outlined as follows.

2008-2009 - Newark and Sherwood Rushcliffe

2009-2010 - Mansfield Hyson Green / St Ann's

2010-2011 - Ashfield **Broxtowe**

Learning difficulties / Physical disabilities/ Special Needs

The coordinator for this arena is the St John Ambulance service, which oversee the strategic planning, in relation to specific activities and referrals. Any work performed with individuals within this area of need is performed and ratified in partnership with the qualified teaching staff at the Portland College in Mansfield who are lead agency for special needs.

Example: The Schools Officers workshops will address specific areas, aimed at reducing crime and victimisation. This will include education, help and advice, regarding issues highlighted by Operation's LIBERAL and RESPECT.

Media and publicity

This has been a significant part of the project, which not only raises awareness to the achievements of the imitative and the young people involved but also gives publicity, credibility and project profile to encourage other young people to have a willingness to be involved. The process has included Press coverage in both local and County newspapers along with radio interviews and coverage of related events. Nottinghamshire Police also cover the project events on their website. The BBC are currently looking at profiling the project over its 10 month period as a documentary following the students through their experiences. (See Appendices F & G – sample media/ press release and Nottinghamshire Police Website screenshot). As part of the planned expansion it is anticipated that the initiative will have its own website that provides an accessible interface for students, families, project workers, referral agencies alike.

Achievements and qualifications

Successful students completing the project are rewarded with multi agency awards in the form of formal certification and in relation to specific training with St John Ambulance each student receives the formal National qualification in first response basic life support. BUSINESS PLAN FOR: "THREE 9'S CHALLENGE"

A challenge for all aged from 10-16 Years

BRIEFING NOTE:

This business plan is a sustainable, multi-phased intervention programme.

DESIGNED FOR:

- 1. Young people aged between 11-16yrs, at risk of disaffection. (Victimisation, Reprimand, Final Warning, Social Difficulties, Truanting)
- 2. People with learning difficulties and / or disabilities.

The launch commenced in August 2005, with ongoing development modules taking place during the holiday periods of, February, April and May 2006.

The operation will be evaluated during the months of June and July 2006.

APPLICATION FORMS

EVALUATION

Short term:

Each young person will have the opportunity to give feedback at the end of each module

How?

By contributing to a short questionnaire. A member of staff or volunteer, within their allocated group, will complete this.

Long term:

This will be a joint agency approach and will include the monitoring of the associated risk factors, relevant to that respective individual.

How?

The comparison of statistical data will evidence areas of required development, for example, truancy & attendance.

FUNDING

Funding has been secured from Connexions PAYP (positive activities for young people) to the amount of £1,500.00.

This will sustain the funding for activity provision only through out a 10 month period.

SUSTAINABILITY/ PROGRESSION

Applications are currently pending for long term sustained funding over the next five year period. To include plans to expand/develop the project in other areas of the county.

2008-2009 – Newark and Sherwood Rushcliffe

2009-2010 - Mansfield Hyson Green / St Ann's

2010-2011 – Ashfield Broxtowe

Each young person accepted on to the project, will be monitored and mentored throughout the 10-month period. This will involve multi-agency tasking involving Youth Services, Schools, Youth Offending Teams, Education Welfare Service, Council ASB teams and Police. This process will take place both with schools and with neighbourhoods.

LEARNING DIFFICULTIES / PHYSICAL DISABILITIES

The lead organising agency for this part of the project is St John Ambulance, through Darren ALCOCK, who will be coordinating the strategic planning, in relation to specific activities and referrals.

The Schools Officers workshops will address specific areas, aimed at reducing crime and victimisation. This will include education, help and advice, regarding issues highlighted by Operation LIBERAL and RESPECT.

Health and Safety Policy

Throughout the Three 9's Challenge, The facilitators all consider that high standards of Health and Safety are of key importance in enabling them to achieve the schemes objectives.

The facilitators will ensure, as far as reasonably practicable, that all reasonable steps to provide a health, and safe environment for all facilitators and participants will be taken.

The Three 9's Challenge is committed to planning, implementing and reviewing its health and safety arrangements in order to achieve continual improvement in performance.

This Policy has been set into place to protect all facilitators, participants and spectators in any of the phases. All aspects of health and safety must go through the appointed person for each phase of the challenge.

FIRE EVACUATION PROCEDURES

Any venue that is used for the Three 9's Challenge must have a pre assessed fire evacuation procedure. This must be obtained from the facility before the commencement of the phase.

The facilitators will be responsible for the group in the case of an emergency and must follow the correct evacuation procedures. The Challenges Fire Service representative will be the facilitator in charge of any fire evacuation situation.

RISK ASSESSMENTS

A risk assessment is essential to avoid harm and promote safety and welfare of all involved in the Three 9's Challenge.

Any phases being run by the Three 9's Challenge will be thoroughly risk assessed to reduce any chance of harm coming to any of the participants.

FIRST AID

Within the Three 9's Challenge, there will always be a qualified first aider on site to deal with any emergency, and first aid kits will be available at each venue. All facilitators will have access to a working telephone.

On any occasion that first aid is administered, an accident report form must be filed as soon as reasonably possible after the event, and passed through the First Aid Co-ordinator Darren Alcock (St John Ambulance).

CHILD PROTECTION POLICY

The Three 9's Challenge operates a child protection policy under the Nottinghamshire County Councils Child Protection Policy and all facilitators will be made aware of this. Ensuring the safety of all young people.

EQUAL OPPORTUNITIES

The Three 9's Challenge affirms that every individual should have the opportunity to take part in any of the phases. We aim to offer opportunities that support individuals with motivation to participate in their chosen activity irrespective of their background.

The Three 9's Challenge aim to ensure that all phases offered are equally accessible to all members of society whatever their age (Within the age guidelines, as this is a youth project), ability, gender, race, ethnicity, sexual orientation, religious beliefs or socio-economic status.

Each facilitator will actively, overcome their own prejudices, respect differences and treat individuals fair and with dignity and make sure that no Three 9's Challenge procedures are discriminatory.

Young people set to take up the Three 9's Challenge

Retford Schools Officer Pc Dave Case said: "It is all about integrating people together. The school holidays could be a time when young people become a victim of crime or become involved in crime or anti-social behaviour themselves."

Nearly fifty young people will graduate from the Three 9's Challenge this week.

The graduation will take place on Thursday 1 June 2006 at the National Watersports



Centre in West Bridgford, Nottingham.

Before the youngsters graduate they will face the fourth phase of the challenge - The White Water Challenge. The participants will be involved in various water activities such as raft building and racing to Bell Boat racing, which is similar to oriental dragon boat racing.

Representatives from the emergency services will also be on hand to demonstrate the different aspects of their work. Demonstrations will be carried out by Nottinghamshire Fire and Rescue Service's water response team, St John Ambulance, who are bringing two emergency ambulances, and Nottinghamshire Police's Dogs and Mounted Section.

The Three 9's Challenge has been organised by Schools Officers from Nottinghamshire Police with Nottinghamshire Fire and Rescue service.

The schools officers involved are PC 932 Paul Kanikowski and PC 1194 Martin Tristram, from South Nottinghamshire Division and PC 641 Dave Case and PC 1910 Andrew Hand, from Bassetlaw, Newark and Sherwood Division.

The multi-agency event has been funded by Positive Activities for Young People (PAYP) and the Big Lottery Fund administered by Connexions Nottinghamshire.

Schools Officers, Crime Reduction Officers, Fire and Rescue Service, the Road Safety Team, St John Ambulance, Sporting Chance, Notts Trading Standards and other partners have all been involved.

There have been three previous Three 9's Challenge events held, which attracted children from all over the county. The young people, who are aged 11 to 16-years-old, have taken part in team building activities and have also learnt about first aid and gained a qualification; personal safety; crime prevention, sexual health and fire and road safety.

PC Paul Kanikowski says: "The Three 9's Challenge has been about having fun but also ensuring that people leave with practical skills and a greater understanding of the role the emergency services play.

"It's been a terrific opportunity for people to make new friends and develop skills that may assist them later in life. It's been very successful and we are looking to repeat the Three 9's Challenge next year."

PC Dave Case adds: "A culmination of 10 months hard work by these young people will be celebrated at this event. It's a credit to how hard they have worked."

The day will run from 10am -3pm and the children will also enjoy a barbeque provided by the centre before receiving their certificates.
