


Investing in Training for Police Works

When leadership changes, it's not uncommon to see significant reductions in violent crimes and police use of force

Professionalizing the police force with better management techniques, technology, and training may be a viable way for cities to rapidly reduce gun violence without exacerbating the harms from policing, even without major new resource investments or shifts in police department strategies

OCTOBER IS DOMESTIC VIOLENCE AWARENESS MONTH

Man who died after trading fire with police in Madison Kwik Trip was wanted for homicide



- More than 10 million adults annually
- 23.2% of women have experienced severe physical violence by an IP
- An abuser's access to a firearm increases the risk of femicide by 400%
- 96% of all murder-suicide victims are female


- 2020 Homicides: 10, 4 DV related 40%
- 2021 Homicides: 10, 2 DV related –
 20%
- 2022 Homicides: 6, 2 DV related 33%
- 2023 Homicides YTD: 9, 4 DV related – 44%
- 2024 Homicides: 5, 3 DV related –
 60%
- Of all domestic homicides since 2020 (15), 11 of them were IPV

- Of the 12 IPV cases:
 - 5 firearms related
 - 3 knife/cutting instrument
 - 1 blunt object
 - 2 asphyxiation
- 5 cases had no previously reported DV history *
- 1 reported, 2 reported, significant
 - Outstanding PC from 2 months prior

Sensitive Crimes Unit

- Previously had district Detectives that took a variety of cases
- February 2025: Implementation of 2 Sensitive Crimes Unit
- Assigned to investigate all domestic violence cases
- Total of 12 Detectives, split into two teams of 6, morning shift and afternoon shift
- Work directly with DAIS, Dane Co Victim/Witness and the DA's office





February 2025: Implementation

• YTD: 3 homicides, 1 DV (father and son) and no IPV homicides

2022- 2,845 CFS for a total of 13,312.15 hours

2023- 2,989 CFS for a total of 14,595.18 hours

2024- 2,643 CFS for a total of 13,686.33 hours



An area in the Lindsay Heights neighborhood has been a consistent hotspot for violent crime.

02

Both mobile drug dealing and open drug use are common citizen complaints, and firearm-related aggravated assaults have gone up, with non-fatal shootings showing a sharp rise.

Businesses have relocated from the area, leaving behind vacant lots and neglected properties. These empty spaces have created conditions where illegal dumping has become more common, contributing to blight and further challenges for the neighborhood.

Crime Analysis was utilized to look at types of crimes, types of calls, locations, targets, trends, and offenders.

From 2022 to 2024, every
Homicide occurred between 11pm
and 3am. 35% of Non-fatal

and 5am.

Two problematic locations that were responsible for the majority of Calls for Service/Violent Crime were identified.




We connected with neighborhood leaders and held meetings to hear their concerns and talk through ideas for making the community better.






004th District Geographical Considerations

- Uniquely situated on the Southeast Side of Chicago and borders the State of Indiana; the village of Burnham; and three (3) Chicago Police Department Districts.
- Straddled by two major thoroughfares, the Bishop Ford Freeway and Lake Shore Drive (U.S. Highway 41)
- Another major thoroughfare traversing through is the Chicago Skyway, an elevated toll bridge providing a connection from Indiana into Chicago







SCANNING - DEFINING THE PROBLEM



CPD often responds to issues after they arise, rather than proactively adjusting to changing conditions.

Reactive vs Proactive

An increasingly dangerous environment that exposes officers to law suits and weakens the pursuit of justice through weaker prosecutions.

CPD's compartmentalized unit structure slows down investigative processes.

Interagency and inter-district collaboration remains siloed, relying heavily on CPIC as the central conduit.

(Centralized vs Decentralized)

Limited training for officers working in a district.

An increase in crime leads to high demand on law enforcement resources, further strained by limited capacity and manpower shortages.

ANALYSIS – LEARNING ABOUT THE PROBLEM



"Lesser Offenses"

Analyzed violent crime which revealed "Lesser" included offenses are often times precursors to more violent crimes.

Partnerships

Assessed interagency partnerships with surrounding districts and nearby police departments to understand coordination and resource sharing.

Crime Trends

An analysis of 2023 crime trends identified a clear correlation between robbery sprees and incidents of homicide and gun violence.



Deployments

Evaluated our current deployments (Tact & Watch), District Strategic Plan, and discretionary resources.

Crime Analysis

A comprehensive crime analysis was conducted to evaluate the nature of offenses, categorize call types, identify high-impact locations and targets, detect trends, and understand offender profiles.

Community

Community concerns were addressed through active participation in meetings and hosting table top conversations with the District Commander.



004th District Led Area 2 Blitz Missions - July 2025

Recognizing the frequent occurrence of crimes extending across district boundaries, a proactive approach involving multiple law enforcement partners becomes essential. To address this challenge, the 004th District coordinates semi-annual Blitz missions involving various agencies at the federal, state, and local levels. During these missions, officers carry out parole checks, traffic operations, premises inspections, surveys of vacant buildings, warrant checks, CTA station patrols, and liquor license inspections. These efforts aim to ensure a visible police presence and to apprehend offenders involved in violent crime who may be operating across different areas.

CPD/ATF JOINT OPERATION

From November 2022 to February 2023, the CPD 004th District Intelligence Team, in collaboration with the ATF, carried out an extensive investigation into a resident of the 004th District engaged in the production and distribution of Privately Made Firearms (PMF's), commonly referred to as "ghost guns".

CPD/FBI JOINT OPERATION

- In November 2022, 004th District Intelligence Team was in contact with the property owners of a nefarious building in the 7700 block of South Muskegon. The building is known for prostitution, gang activity, and narcotic sales. The 004th District Intelligence team obtained a consent to search from the property owner and collaborated with the FBI Group CE02 to develop a plan for conducting said operation in a safe and efficient manner. Mr. Mckay was later adopted federally as a Project Safe Neighborhoods case.





Prolific Parole Check

On August 1, 2023, James Woodson, a documented member of the Black P. Stone - No Limit Gang, was the victim of an aggravated battery. Various sources indicated that Mr. Woodson is highly likely to retaliate for this attack. In response, officers from the 004th District, along with IDOC Parole Agents, conducted a parole check with the goal of preventing further violence.

Recovered from Mr. Woodson's parole residence were:
